**Dear Sir Mark,**

I am contacting you as a serving Member of Parliament. I seek an urgent meeting with you and senior Metropolitan Police Detectives to discuss some very serious and concerning issues that have been brought to my attention regarding the Coronavirus pandemic response and the vaccination programme.

This is a matter of paramount importance for the well-being and safety of the British public. I and others deem this to be a national emergency having identified a litany of failures and cover-ups that can no longer be ignored. The usual routes via the standards committee, government departments, regulators and Civil Service have all been dismissed or ignored.
