

Tests showed that she had elevated lipase levels, which can potentially indicate cancer, pancreatic issues and other serious health conditions. While a lipase level of 100 is typical, Emily's had reached 10,000.

MORE DETAILED STORY:



I was for work, 6 months later, I was hospitalized with severe acute pancreatitis. Doctors thought it was a fluke given my age and health and given the fact that I bounced back immediately. But then it happened again 6 months later. Then they said I should see a GI doc. But being a 36 yr old mom of 4 in school and working, I didn't see the urgency until the pain was back and unrelenting a few months later. I saw a GI doc and showed up extremely itchy and extremely yellow. It made no sense, but he went with his gut and did a biopsy. Turns out, I had stage 2b PDAC. The bad kind. While caught early, it was wrapped around my blood vessels, preventing me from getting the whipple. I did 6 months of chemo, which thankfully shrunk the tumor away from the blood vessels, yet by the time I had my whipple, the tumor that removed was nearly twice the size since diagnosis. The chemo, Folforinox, couldn't keep up with the tumors growth. After a horrible nightmare with my whipple, I was told two things. 1. They ran a full genetic panel, assuming it was genetic given my age and health. Nothing, It's NOT genetic, 2. My scans are clear. They got it all!

But they didn't. Instead of getting better, i was actually declining. I kept bringing up my issues with my doctor, especially concerning symptoms associated with this cancer, the pale colored floating stools. She insisted it was "all in my head," and my symptoms were caused by depression. She prescribed me a sleeping pill and sent me to therapy.

But then my CA-19 tumor spiked. They didn't seem worried. I had a CT scan. I read my report on MyChart. I had a new fricking tumor damn near the same size as the first. In just 8 months. They called days later. Unconcerned and in no rush to schedule my follow-up PET scan. Or now a mammogram? I need a mammogram now bc all these scans for pancan has picked up a new spot that keeps getting bigger!?!?! But they refused to schedule that. Drug their heels on scheduling the PET scan.

I arranged to travel out of town to MD Anderson. I requested my records be sent weeks prior to my departure. I brought my PET scan with me due to timing. Everything was sent, but that recent CT scan. A week before we leave, they still haven't. We leave and get there. They still haven't sent it. We've been on the phone with them and continued the entire time were out of town for the appt. Asking why they haven't sent it? They've had weeks now. And they know their tumor boards meets! They can't plot out treatment without it! And they were concerned. Bc tucked away in my medical records was a note about my post op pathology report showing a positive margin. That they completely ignored. And according to the PET, my recurrence lines up with it.

At this point, my oncologist is made aware and wish to be treated STAT! She flat out refused. I was offered to go to THEIR clinical trials. I asked for a new doctor. A patient "advocate" called me and told me that all doctors refuse to accept me as a patient. I told her that my doctor was denying me treatment for a life threatening disease and refusing to release my records. This non doctor patient "advocate" then proceeds to tell me without skipping a beat and not even looking at my chart says "We dont even know if you even HAVE a tumor to begin with!" It's clear as day on both scans.

Now, it was after that phone call with the nurse about that first CT scan that something in my gut told me something was off. It was around this time my mother in law convinced to try ivermectin. I figured at this point it would hurt. So I started a protocol, if you will. I had already taken it for about 2-3 weeks by the time I made my trip for that second opinion. It was then they drew my blood to measure my CA-19 tumor marker. It was lower.

My Take:

To summarize this complicated story:

• 36 year old mother of 4 was diagnosed with Stage 2 Pancreatic Ductal Carcinoma (PDAC), wrapped around her blood vessels, preventing her from getting surgery.

- She did 6 months of chemo, which shrunk the tumor away from the blood vessels just enough to allow her to have surgery (Whipple procedure).
- The tumor that was removed, however, was twice the size of the original tun indicating the Pancreatic Cancer had already overcome the effects of the cheven before the surgery and had been growing again very quickly.
- Surgeons claimed they got it all but they didn't (post op pathology report she positive margins but no one caught it and no one seemed to know)
- She had ongoing symptoms but wasn't taken seriously by Oncologists.
- Her cancer markers CA-19 spiked and sure enough, 8 months after surgery s
 was diagnosed by CT with a Pancreatic cancer recurrence, nearly the same s
 as the 1st tumor, but her Oncologists refused to treat her and tried to put he
 a trial of some kind.
- She went to MD Anderson for a second opinion.
- This is where she starts taking Ivermectin on the advice of her mother in law "my mother in law knew of Dr.Makis and his research").

Explanation:

- How do I explain what happened here?
- During the 3 months that she was diagnosed with a LOCAL Pancreatic cancer recurrence but her Oncologists refused to treat her, the Ivermectin definitel stopped the tumor growth.

- Ivermectin inhibits metastasis (2022 Jiang et al: "Ivermectin inhibits tur metastasis by regulating the WNT/B-catenin/integrin b1/FAK signaling pathway")
- Ivermectin reverses chemo drug resistance, allowing chemo to kill more cancer cells (2019 Jiang et al: "Ivermectin reverses the drug resistance in cancer cells through EGFR/ERK/Akt/NF-kB pathway")
- Ivermectin sensitizes cancer cells to radiation, allowing radiation to kill more cancer cells. (2020 Mudassar et al: "Targeting tumor hypoxia and mitochondrial metabolism with anti-parasitic drugs to improve radiatio response")
