# Germany's Largest Health Insurer Reveals 1 in 20 Vaccinated Require Medical Treatment by Craig Paardekooper

Techniker Krankenkasse recently disclosed the billing data on vaccination side effects from 2021. According to this, around 437,593 cases related to vaccination side effects were billed for the year as a whole. TK is Germany's largest health insurance company with around 11 million insured persons.

### Year by year

- 2021: 437,593 out of 11 million insured, or **1 in 25**, received medical treatment for side effects of vaccination, reported the Techniker Krankenkasse (TK). In Germany, 80% of the population are vaccinated, so the actual numbers are 437,593 out of (11 million x 0.8) 8.8 million insured, or **1 in 20**.
- 2020: 15,044 out of 11 million insured received medical treatment for side effects of vaccination.
- 2019: 13,777 out of 11 million insured received medical treatment for side effects of vaccination.

So 437,593 of the 11 million insured persons of Germany's largest Health Insurance Fund - TK - had to undergo medical treatment in 2021 for vaccine side effects.

IF all 11 million were vaccinated, this would be an adverse event rate of 1 in 25.

However, it is doubtful that all 11 million were vaccinated. Let us say 80 % were vaccinated - i.e. 8,800,000. Then the adverse event rate is 1 in 20.

So 1 in 20 required medical treatment after vaccination.

#### **Keeping Beneath the Radar of Public Awareness**

1 in 20 is precisely the level necessary to maximize adverse effects, whilst convincing the public that the effects are random chance.

In scientific experiment, the 5% level is often taken as the level of significance showing when an effect IS due to a controlled variable rather than due to random variation within a sample.

So to inflict harm AND be discrete, a government would aim to keep the incidence of effects at a 5% level.

What is CERTAIN from this report is that the COVID 19 vaccines cause a catastrophic incidence of harm. 1 in 20 is HUGE. It removes the COVID vaccine from the realm of incompetence into the realm of deliberate and intentional homicide - from the realm of bad medicine into the realm of bio-weapon.

#### **How Many Injuries in the Entire Population**

76% of the population have been fully vaccinated in Germany = 83 million x 0.76 = 63,000,000 vaccinated If 1 in 20 require medical treatment following vaccination, then that equates to 63,000,000/20 = 3.1 million cases requiring medical treatment in Germany alone.

## Confirmation by a Letter from the National Association of Physicians of Statutory Health Insurance

At the beginning of July, German news channel WELT obtained a letter from the National Association of Physicians of Statutory Health Insurance (KBV) .The KBV letter from mid-June revealed that nearly 2.5 million citizens went to the doctor in 2021 because of the side effects of the corona vaccination.

A request to the National Association of Statutory Health Insurance Physicians (KBV) from March 2022 released the following data -

- 2021 : 2.5 million cases of vaccination side effects were treated with around 172 million vaccine doses administered.
- 2020: 76,000 side effects with around 30 million doses administered
- 2019: 70,000 side effects with around 25 million doses administered.

#### **Data from BKK-Provita**

BKK board member Andreas Schöfbeck provided alarming figures. After a large-scale internal investigation of the company health insurance, with around 11 million insured persons, Schöfbeck came to the conclusion that there was "a very significant underreporting of suspected cases of vaccination side effects".

"If these figures are extrapolated for the year as a whole and for the population in Germany, probably 2.5-3 million people in Germany received medical treatment because of side effects of vaccination after corona vaccination."

So BKK-Provita calculated that out of 11 million insured persons, 1 in 20 vaccinated were requiring medical treatment.
